Minimum

The food and beverage minimum in the private events room before tax and gratuity is \$1500 Friday through Sunday and \$1000 Monday through Thursday.

Room Charge fee, Tax and Gratuity

There will be a \$250 nonrefundable room charge fee that is due upon booking your event to secure your date. A gratuity charge of 20% is automatically added to your invoice. All food, beverage and additional charges are subject to 8% state and local taxes unless documented proof of exemption is provided. Should your organization be tax exempt, we will need advanced notice and a copy of your tax-exempt form for our records.

Guest Count

A guaranteed guest count is to be submitted 7 days prior to the event. If there is a change in the count, please contact your event coordinator who will try to accommodate the changes if guest counts increase. This count is a guarantee and not subject to reduction if your guest count decreases.
