New Business

CALINA HOLDINGS-Robert Laubacker PSP-2025-001 Lkpt Junction Rd., Lkpt SBL#121.00-2-26.1 Site Plan (preliminary)-Office, warehouse, storage

Mr. Laubacker was present. He explained that he builds cemeteries for veterans all over the country. He would like to build the home base for his business here in Cambria. He would like a 40° x 60° office, with a 60° x 100° - 120° shop behind it. In the front of the property a commercial industrial park with 60° x 100° for the offices. He proposes they build the office, shop and one building as the first phase. If they are successful, they would go on to build the other phase.

He has purchased this property already.

He has engineers working on further plans for him. Chairman Amacher explains that Mr. Laubacker or our building department will have to talk to Tim Walck who is our Town engineer.

The buildings will be powered by propane, and they will use Town of Lockport's waterline. Each unit will have a restroom. There will be black top, a berm, and trees. They hope to break ground at the end of summer.

The Niagara County Planning Board approved this project.

Architectural plans and stormwater drainage will come later.

A motion to table the Site Plan until next month was made by Mr. Meal and seconded by Mr. Schreader, all in favor, so carried.

Reports

Mr. McCann brought up the Conex box definition that needs to be sent to the Town Board so they can have a public hearing.

Chairman Amacher asked if all the members got copies of the letter of intent for the Unicorn Drive project, which they did. There have been no more plans submitted. The contract itself is contingent upon receiving several approvals, according to attorney Platt. A brief further discussion ensued.

He was under the impression it was taken care of last year. It seems to be a neighbor dispute. Their approval will not be rescinded.
