• 1115 Waiver:

 Discussion around the waiver are still continuing. Conversations being handled by Office of Health Insurance Programs. Would like to include loan repayment programs in the waiver focused on dentists and on psychiatrists.

Carrie Roseamelia: Introduced the Office of Healthcare Workforce Innovation and supporting the healthcare workforce.

Office of Healthcare Workforce Innovation

- Mission is to increase the supply of healthcare workers and direct support personnel.
- Strategic Plan:
 - Collaboration agencies, industries, healthcare leaders, providers, educational organizations, employers, labor unions, key stakeholders to inform the objectives of the center
 - Distribution grants and programs (Increasing Training Capacity and Statewide Healthcare Facilities Grant, AHEC – community based pipeline programing for underserved and marginalized areas including rural)
 - Regulations, Policy and Research Apply a more data driven approach to policy recommendation and future programs.

Cheryl Dallesandro: Discussed Division of Workforce Transformation and their support for the healthcare workforce.

Division of Workforce Transformation:

- Partnership with the Primary Care Office Cooperative Agreement with HRSA.
 Designates the health professional shortage areas in New York State. Also, works to designate the medically underserved populations and areas in New York State.
- Focus on providing different programs and increasing access to the underserved.
 - Goal is to place and train healthcare workers in the underserved areas of New York State.
- Programs:
 - Loan repayment programs: Doctor's Across New York, Nurses Across
 New York and Primary Care Service Core

Discussion	Stakeholder Discussion Summary:
	 Challenges in recruiting and retaining healthcare professionals, particularly in underserved areas.
	 Advocacy for support in home health agencies and community health agencies. Urgent need for support in addressing the dental crisis, including the introduction of the dental therapist program. Challenges in teacher certification requirements for Nurse Assisting.
	 Exploration of alternative models for clinical supervision in schools.
	 Call for interdisciplinary conversations to address regulatory barriers and criteria for healthcare professions.
	 Urgency in finding immediate solutions and long-term strategies to address the workforce crisis.
Next Steps	Common Ground Health will continue to utilize monthly healthcare workforce newsletter to share updates to the community.
	Common Ground Health will lead continued community conversation, input collection and collaboration between partners and New York State.
	 Consider convening an interdisciplinary group to address structural issues in healthcare professions.
	 Explore policy changes and cultural shifts to facilitate access to healthcare professions.
	 Evaluate existing programs and consider tweaks for a more efficient and responsive system.
	 Establish ongoing communication channels for stakeholders to provide input and suggestions.
